NOW, THEREFORE, to give notice of the matters set forth herein, the undersigned, being the President of the Association, does hereby certify that at the Adoption Meeting, at least a majority of the directors of the Board were present and the Board duly adopted the Leasing Information Policy. The Leasing Information Policy is effective upon recordation of this Certificate in the Official Public Records of Harris County, Texas. The Leasing Information Policy is as follows:

LEASING INFORMATION POLICY

- Information. At the Board's discretion, the Association may, but is not required to, send a property owner a written request to submit the following information to the Association regarding a lease or rental applicant:
 - Contact Information, including the name, mailing address, phone number, and e-mail address of each person who will reside at the property in the Community under a lease; and
 - b. The commencement date and term of the lease.
- Time Frame. The above information, if requested by the Association, shall be provided to the Association's then current Community manager on or before the time frame set forth in the Association's written request.
- Notice. Notice to the Association must be sent to the Association's then
 current Community manager. Notice to the owner may be sent to the owner
 by email. An email address provided by the owner or used in
 communication with the Association shall be sufficient.
